



PHYSIOTHERAPY

ICBC has an agreement with the Medical Service Plan to act as ICBC's billing agent. All authorized motor vehicle related invoices for physiotherapy treatment are to be processed through Teleplan at the following rates.

FEE CODE	TREATMENT DESCRIPTION	ICBC FEE
9904	<i>Initial Visit:</i> Includes evaluation and treatment. May be paid only once per year unless three clear months since last treatment.	\$25.20
9902	<i>Subsequent Visit:</i> A short evaluation and either treatment or instruction on home exercise and care of the condition, requiring less than 25 minutes of direct contact with the patient	\$17.65
9933	<i>Prolonged Visit:</i> Assessment and treatment, and may include instruction on home exercise and care of the condition, requiring at least 25 minutes of direct contact with the patient	\$23.60
9934	<i>Prolonged Visit:</i> Assessment and treatment, and may include instruction on home exercise and care of the condition, requiring at least 10 minutes of direct contact with the patient, plus an additional 30 minutes of supervised treatment or exercise	\$23.60
9935	<i>Prolonged Visit, CNS:</i> Assessment and treatment of central nervous system (CNS) disorders/conditions, requiring at least 35 minutes of direct patient contact. CNS disorders may include head injury, hemiplegia, muscular dystrophy, multiple sclerosis, etc.	\$35.90
9908	<i>Home Visit:</i> Requires the therapist to travel to the patient's home for assessment and treatment	\$28.70
9903	<i>First additional area</i>	\$6.75
9913	<i>Second additional area</i>	\$6.75
9914	<i>Third additional area:</i> Up to three additional areas may be billed	\$6.75

CHIROPRACTIC

ICBC has an agreement with the Medical Service Plan to act as ICBC's billing agent. All authorized motor vehicle related invoices for chiropractic treatment are to be processed through Teleplan at the following rates.

FEE CODE	TREATMENT DESCRIPTION	ICBC FEE
00130	<i>Initial Visit:</i> Initial office visit by a patient to a chiropractor for any new condition seen for the first time, including consultation with patient and advice and any treatment on that date.	\$22.27
00137	<i>Subsequent Office Visit</i>	\$17.35
00136	<i>Emergency, night, or holiday visit (0136)</i>	\$34.85
00133	<i>Home Visit</i>	\$27.05
